Second pre-Summit discussion on regulatory challenges emerging from a transition of the energy system due to decarbonisation and actions for European energy regulators

The second pre-Summit discussion follows-up on the discussion in October and aims to explore high-level considerations on regulatory actions under the areas identified by the WGs Chairs and HoDs with a view to the BoR Summit in January. **Relevant documents and presentations are uploaded to the BoR meeting page.**

Opening: Recap of discussions and conclusions so far (BoR Chair) (5 mins)

Session 1: Regulatory challenges emerging from a transition of the energy system due to decarbonisation and actions for European energy regulators

1. Sector Integration (25 minutes) - Towards a holistic energy system to serve decarbonisation

Introduction by ACER Electricity and Gas HoDs (10 minutes) on exploring challenges and actions by European energy regulators (scoping high-level considerations):

- *Decarbonising the energy system* (e.g. sector coupling, guarantees of origin).
- *Overcoming inefficient use of infrastructure and incoherent investment frameworks* (optimising network planning, developing interlinked models, efficient infrastructure development, lack of coherence in investment frameworks, uncertain gas demand / risk of stranded investments, efficient use of cross border capacity).
- *Is our governance fit for purpose in a more integrated system?* (Role of TSOs and DSOs in new activities, strengthening regional cooperation, oversight of new entities including those taking over TSOs tasks).
- *Ensuring a level playing field* (e.g. for technology and support schemes and funding).
- *Intervention by 2 members (max. 5 minutes each) and open discussion (total 35 minutes)*

2. Electricity (30 minutes)

Introduction by AEWG Chair (10 minutes) on exploring challenges and actions by European energy regulators (scoping high-level considerations):

- *Finish what we started* (electricity target model and full implementation of NCs).
- *Facilitating decarbonisation at least cost and serving the energy system* (e.g. impact of RES policy on: pricing of energy, generation adequacy and security of supply, BZ configuration, optimal use of infrastructure).
- *Intervention by 2 members (max. 5 minutes each) and open discussion (total 30 minutes)*

3. Gas (30 minutes)

Introduction by AGWG Chair (10 minutes) on exploring challenges and actions by European energy regulators (scoping high-level considerations):

- *Alignment of the gas legislation* (e.g. institutional framework, regional cooperation, gas quality review).
- *Upgrading the regulatory framework* (e.g. tariffs, LNG/storage, illiquidity and market power).
- *Facilitating decarbonisation at least cost and serving the energy system* (e.g. deployment of renewable and low carbon gases (incl. hydrogen and green gases)).
- *Intervention by 2 members (max. 5 minutes each) and open discussion (total 30 minutes)*

4. Wrap up including other cross-sectoral key objectives (10 minutes)

Introduction by BoR Chair (10 minutes) on exploring challenges and actions by European energy regulators (scoping high-level considerations):

- *Facilitating innovation, empowering consumers, and enabling system savings* (e.g. digitalisation/technological advances, consumer concerns) - potential links with CEER work.
